Examination Types:

The process time amounts generally four months. The candidates of mathematical or empirical thesis can apply for an extension of the deadline up to five months in consultation with the chair. The application for the extension has to be handed in the audit committee.

Requirements for Award of Credit Points:

Successful participation of the master thesis. The master thesis will be passed if the grade is at least „sufficient“ (4,0).

Availability:

Writing the master thesis will be offered generally each semester.

Assessment:

This course will be graded and is part of the calculation for the overall grade of your master degree. Particular information concerning the calculation of the overall grade can be gathered in the respective examination regulations.

Person Responsible and Main Lecturer:

Professors, unscheduled Professors, honorary professors, private lecturers, junior professors and assistant lecturers - Retired professors can be ordered as examiners for the duration of two year after they were retired from the Heinrich-Heine-University.

Further Information:

The assignment takes place via the first supervisor at the audit committee of the faculty. The subject of the thesis can be withdrawn without mentioning the reasons until two weeks after the output of the topic. This opportunity can only be used once. The master thesis counts by withdrawing as not set in.
