In the research colloquium "Empirical Management Research", content-related and methodological aspects of empirical management research are presented and discussed. In

- Lectures from scientific projects of the participating chairs with subsequent discussion,
- lectures by national and international guest speakers,
- workshops for the development and discussion of publications,
- software and methodology courses,
- classes for the acquisition of scientific key competencies, e.g., Academic English, presentations at international conferences, etc.

Language:

The language of the module is German. For required readings or classes and presentations in English, sufficient language skills are a prerequisite.

Teaching Methods:

Lectures, problem-centered learning, group work, self-study.

Admission to the master's program "Business Administration" or an equivalent degree program. A large part of the course literature or course content is taught in English, so a good to very good knowledge of English is a prerequisite.

The final module examination consists of comprehensive examination in the form of a written paper including a presentation.

Successfully passed final module examination. A module final examination is passed if the evaluation is at least "sufficient" (4,0).
